- Handling student concerns/problems and referring to the presiding invigilator where appropriate
- Reporting anomalous situations
- Verifying student identification
- Making assessment related announcements to students
- Invigilators are required to attend a paid-orientation session.

- Applicants must be available for in-person invigilation
- Work shifts will vary and happen between 17 October 2024 and 30 April 2025
